## Introduction

These rules govern the way that we operate the SRA Compensation Fund. This is a discretionary fund of last resort for making grants to people whose money has been stolen, or has not been accounted for, as a result of the acts or omissions of those regulated by us, and to relieve losses for which firms authorised by us should have had, but did not have, insurance.

It is funded by contributions from individuals and firms authorised by us.

We have provided guidance on the way we operate the fund.

#### Rule 1: Maintenance of and contributions to the Fund

- 1. The <u>SRA [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> shall establish and maintain a fund for making grants in respect of claims made in accordance with these rules.
- 2. <u>Solicitors</u> [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#solicitor], RELs [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#REL], RFLs [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#RFL], recognised bodies [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#recognised-body] and licensed bodies [https://media.sra.org.uk/solicitors/standards-

- 3. Any unpaid contributions may be recovered as a debt due to the <u>SRA [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u>.
- 4. The <u>SRA [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may at any time:
  - 1. borrow for the purposes of the <u>Fund</u> [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#Fund];
  - 2. charge investments which form part of the <u>Fund</u>

- 2. The <u>Fund [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#Fund]</u> is a discretionary fund of last resort and no <u>person</u> [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#person] has a right to a grant enforceable at law.
- 3. The primary objects of the <u>Fund</u>
  [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#Fund] are:
  - 1. to replace money which a <u>defaulting practitioner</u>

    has misappropriated or otherwise failed to account for; and

## Rule 3: Grants which may be made from the Fund

- 3. For any grant to be made out of the <u>Fund</u>

  [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#Fund]\_, an applicant [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#applicant]\_must satisfy the <u>SRA</u>

  [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]\_that the applicant [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#applicant]\_is eligible in accordance with rule 4 and (save in respect of a grant made under rule 3.4) has suffered or is likely to suffer:
  - 1. loss in consequence of the dishonesty of a <u>defaulting practitioner [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner]</u> or the employee or <u>manager [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#manager]</u> or <u>OWNer [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#owner]</u> of a <u>defaulting practitioner [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner]</u>; or
  - 2. loss and hardship in consequence of a failure to account for money which has come into the hands of a <u>defaulting practitioner [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner]</u> or the employee or <u>manager [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#manager]</u> or <u>Owner [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#owner]</u> of a <u>defaulting practitioner [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner]</u>, which may include the failure by a <u>defaulting practitioner</u> [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] to complete work for which the <u>defaulting practitioner [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner]</u> was paid,

in the course of an activity of a kind which is part of the usual business of a <u>defaulting practitioner</u>

3. For the purposes of rule 3.1(b):

- 1. an individual whose dealings have been in a personal capacity with the <u>defaulting practitioner</u> [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaultingpractitioner] and who has suffered or is likely to suffer loss due to a failure to account shall be deemed to have suffered hardship; and
- 2. a body corporate, or an individual whose dealings have been in a business capacity with the <u>defaulting practitioner</u> [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-<u>practitioner</u>] and who has suffered or is likely to suffer loss due to a failure to account must provide evidence to satisfy the SRA [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] that it, he or she (the body or individual) has suffered or is likely to suffer hardship.
- 3. The <u>SRA [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may make a grant as an interim measure.
- 4. The <u>SRA [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may make a grant to alleviate direct losses suffered as a result of the civil liability of a defaulting practitioner [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaultingpractitioner] (other than a solicitor [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#solicitor]\_or REL [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#REL] who falls within rule 5.2(b)) or a defaulting practitioner's [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaultingpractitioner] employee, manager [https://media.sra.org.uk/solicitors/standardsregulations/glossary/#manager] or owner [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#owner] in
  - circumstances where:
    - 1. the <u>defaulting practitioner [https://media.sra.org.uk/solicitors/standards-</u> <u>regulations/glossary/#defaulting-practitioner</u>] in accordance with the SRA Indemnity Insurance Rules should have had, but did not have, in place a policy [https://media.sra.org.uk/solicitors/standardsregulations/glossary/#policy] of qualifying insurance [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#qualifyinginsurance];
    - 2. the liability of the <u>defaulting practitioner</u> [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaultingpractitioner] or the defaulting practitioner's [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-<u>practitioner</u>] employee or <u>manager</u> [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#manager] would have been covered by a policy [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#policy]\_of qualifying insurance [https://media.sra.org.uk/solicitors/standardsregulations/glossary/#gualifying-insurance]; and
    - 3. the loss is not covered by the SIF [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SIF].

4. A <u>person [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#person]</u> is eligible under this rule to apply for a grant out of the <u>Fund [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#Fund]</u> where the <u>person</u>

- 1. is an individual: or
- 2. at the time the application is made, is a sole trader, partnership [https://media.sra.org.uk/solicitors/standardsregulations/glossary/#partnership], body corporate, unincorporated association or mutual association with an annual turnover [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#turnover] of less than £2 million,

and does not fall within rule 4.2, 4.3(a) or 4.4(a).

- 5. A person [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#person] is eligible under this rule to apply for a grant in the circumstances set out in rule 3.1(a) if at the time the application is made the person [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#person] falls within one or more of the following categories:
  - 1. a <a href="mailto:charity"><u>charity [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#charity]</u></a> with annual income net of tax in the most recent financial year of less than £2 million; or
  - 2. a <a href="mailto:trustee">trustee</a> [https://media.sra.org.uk/solicitors/standardsregulations/glossary/#trustee</a>] of a trust with an asset value of less than £2 million.
- 4. A <u>person [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#person]</u> is eligible under this rule to apply for a grant in the circumstances set out in rule 3.1(b) if the <u>person [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#person]</u>:
  - 1. at the time the application is made falls within one or more of the following categories:
    - 1. a <a href="mailto:charity">charity</a> [https://media.sra.org.uk/solicitors/standardsregulations/glossary/#charity] with annual income net of tax in the most recent financial year of less than £2 million; or
    - 2. a <a href="mailto:trustee">trustee</a> [https://media.sra.org.uk/solicitors/standardsregulations/glossary/#trustee</a>] of a trust with an asset value of less than £2 million; and
  - 2. has satisfied the <u>SRA [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> that its beneficiaries have suffered, or are likely to suffer, hardship if a grant is not made.
- 4. A <u>person [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#person]</u> is eligible under this rule to apply for a grant in the circumstances set out in rule 3.1(a) or (b) if the <u>person [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#person]</u>:

- 1. at the time the application is made falls within one or more of the following categories:
  - 1. a <u>charity [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#charity]</u> with annual income net of tax in the most recent financial year of £2 million or more; or
  - 2. a <a href="mailto:trustee">trustee</a> [https://media.sra.org.uk/solicitors/standardsregulations/glossary/#trustee</a>] of a trust with an asset value of £2 million or more; and
- 2. has satisfied the <u>SRA [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> that its beneficiaries have suffered, or are likely to suffer, hardship if a grant is not made.
- 5. The <u>SRA [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may take into account such evidence as it sees fit when determining eligibility under rules 4.1 to 4.4 and may make a broad estimate of any relevant amount.

## **Rule 5: Defaulting practitioners**

- 5. The SRA may only make a grant in respect of acts or omissions of a defaulting practitioner [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner], or of a defaulting practitioner's [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] employee, owner [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#owner] or manager [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#manager] as appropriate, which fall within rule 3.
- 6. A <u>defaulting practitioner [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] means:</u>
  - a <u>solicitor [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#solicitor]</u> or an <u>REL</u>
     <a href="mailto:regulations/glossary/#REL]">[https://media.sra.org.uk/solicitors/standards-regulations/glossary/#REL]</a> who at the date of the relevant act or omission was:
    - 1. practising in an <u>authorised body</u> [<a href="https://media.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body">https://media.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body</a>]; Or
    - 2. practising in a <u>non-commercial body</u> [<a href="https://media.sra.org.uk/solicitors/standards-regulations/glossary/#non-commercial-body">https://media.sra.org.uk/solicitors/standards-regulations/glossary/#non-commercial-body</a>];
  - 2. a <u>solicitor [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#solicitor]</u> or an <u>REL</u> [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#REL] who at the date of the relevant act or omission:
    - 1. was self-employed and practising in their own name, and not through a trading name or service company;
    - 2. did not employ anyone in connection with the services they provided; and

- 3. was engaged directly by their clients with their fees payable directly to them;
- 3. an <a href="https://media.sra.org.uk/solicitors/standards-regulations/glossary/#RFL]">RFL | Who is a manager or owner of an authorised body;</a>
- 4. a <u>recognised body [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#recognised-body]</u>; **or**
- 5. a <u>licensed body [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#licensed-body]</u>,

and the expressions "defaulting solicitor", "defaulting REL", "defaulting recognised body", "defaulting RFL" and "defaulting licensed body" shall be construed accordingly.

- 7. A grant may be made where, at the date of the relevant act or omission:
  - 1. a <u>defaulting solicitor [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner]</u> had no practising certificate in force;
  - 2. the registration of a <u>defaulting REL</u>

    [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] or <u>defaulting RFL</u>

    [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] had expired or been revoked;
  - 3. the authorisation of a <u>defaulting recognised body</u>

- 6. The <u>SRA [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may make a grant to a <u>defaulting practitioner</u> [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] who or which has suffered or is likely to suffer loss by reason of their liability to any client in direct consequence of an act or omission of:
  - 1. in the case of a <u>defaulting solicitor</u>

- 7. The <u>SRA [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may make a grant under this rule by way of a loan upon such terms as the <u>SRA [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> specifies.
- 8. In the case of a <u>defaulting recognised body</u>
  [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] Or a <u>defaulting licensed body</u>

## Rule 7: Grants in respect of statutory trusts

7. The <u>SRA [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may make a grant to alleviate a deficiency in a <u>statutory trust</u> [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#statutory-trust] held by the <u>SRA [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u>.

8. The <u>SRA [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may make a grant to a <u>person [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#person]</u> where the money would have been due to that <u>person [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#person]</u> but for their claim having been extinguished under rule 8.2 of the SRA Statutory Trust Rules.

#### **Rule 8: Interest**

- 8. In respect of any grants made under rules 3, 6 or 7 the <a href="SRA">SRA</a>
  <a href="Interest">[https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</a> may make a supplementary grant by way of a sum in lieu of lost interest on the loss underlying the principal grant. Such interest will be calculated by the <a href="SRA">SRA</a> [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] in accordance with <a href="prescribed">prescribed</a> [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#prescribed] rates.
- 9. Where the application for the principal grant is in respect of a failure to redeem a mortgage, the <a href="SRA">SRA</a> [<a href="https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</a> may also make a grant in respect of the additional interest accrued to the mortgage account as a result of the <a href="defaulting\_practitioner's">defaulting\_practitioner's</a> [<a href="https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner">https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner</a>] failure to redeem.

9. Unless the <u>SRA [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> is satisfied that there are exceptional circumstances in the public interest that justify a higher sum, the maximum grant that may be made is £2 million.

- 11. For the avoidance of doubt, the <u>SRA</u>

    - arise solely by reason of professional negligence by a defaulting practitioner [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner], or the employee or manager [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#manager] of a defaulting practitioner [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner], save as provided for in rule 3.4;
    - are indirect or consequential, save where a claim is made for costs of completing or remedying work for which the <u>defaulting</u> <u>practitioner [https://media.sra.org.uk/solicitors/standardsregulations/glossary/#defaulting-practitioner]</u> has been paid, or as otherwise provided for in these rules;
    - 3. are, or result from, the trading debts or liabilities of the <u>defaulting\_practitioner[https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner];</u>
    - 4. are for interest payable to the <a href="mailto:applicant"><u>applicant</u></a>
      <a href="mailto:line-standards-regulations/glossary/#applicant">line-standards-regulations/glossary/#applicant</a>], save where the discretion to make a grant under rule 8 is exercised;
    - 5. are suffered by the Legal Aid Agency as a result of making regular payments under the Agency's contracting schemes for civil or criminal work;
    - 6. are where the <u>applicant [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#applicant]</u>:
      - 1. has been made bankrupt and any grant would vest in the trustee in bankruptcy;
      - 2. has entered into a voluntary arrangement with their creditors and any grant would vest in the administrator of the arrangement; or
      - 3. is in liquidation.

satisfied that the act or omission was, or was closely connected with, the act or omission of a <u>solicitor</u>

#### Rule 16: Application and time limit

An <u>applicant [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#applicant]</u> must make an application for a grant in the <u>prescribed [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#prescribed]</u> form, and within 12 months of the date they first became aware, or should reasonably have become aware, of the loss.
- 17. The <u>SRA [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may extend the 12 month period in rule 16.1 if satisfied that there are circumstances which justify the extension of the time limit.
- 18. The <a href="mailto:applicant">applicant</a> [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#applicant</a>] must provide information, documents and evidence requested by the <a href="mailto:SRA">SRA</a> [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA</a>], which may include verification of matters by statement of truth or affidavit. Failure to provide such documentation or to co-operate with the <a href="mailto:SRA">SRA</a> [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA</a>] will be taken into account when determining the merits of the application.



## Rule 17: Notice to defaulting practitioner

The <a href="SRA">SRA</a> [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</a> may not make a grant unless it has given not less than 8 days' notice to the <a href="defaulting\_practitioner">defaulting\_practitioner</a> [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] informing them of the nature and value of the application, unless it appears to the <a href="SRA">SRA</a> [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] that it would not be reasonably practicable to give such notice, or the grant should be made urgently.
- 18. Where the SRA [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] has made a grant urgently in accordance with rule 17.1, the SRA [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] shall as soon as, and so long as, it is practicable to do so, give notice to the defaulting practitioner [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] in the terms set out in rule 17.1 and may (insofar as any failure to give notice before the making of the grant has prejudiced the defaulting practitioner [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner]) waive in whole or in part the Fund's [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#Fund] right of recovery under rule 18 against the defaulting practitioner [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner].

### Rule 18: Recovery and subrogation
