## Introduction

These rules govern the way that we operate the SRA Compensation Fund. This is a discretionary fund of last resort for making grants to people whose money has been stolen, or has not been accounted for, as a result of the acts or omissions of those regulated by us, and to relieve losses for which firms authorised by us should have had, but did not have, insurance.

It is funded by contributions from individuals and firms authorised by us.

We have provided guidance on the way we operate the fund.

1. The [SRA](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] shall establish and maintain a fund for making grants in respect of claims made in accordance with these rules.

The [Fund](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#Fund) [\[https://media.sra.org.uk/solicitors/standards-regulations/glossary/#Fund\]](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#Fund) is a discretionary fund of last resort and no [person](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#person) [\[https://media.sra.org.uk/solicitors/standards-regulations/glossary/#person\]](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#person) has a right to a grant enforceable at law.

### **Rule 3: Grants which may be made from the Fund**

3. For any grant to be made out of the [Fund](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#Fund), an [applicant](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#applicant) must satisfy the [SRA](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) that the [applicant](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#applicant) is eligible in accordance with rule 4 and (save in respect of a grant made under rule 3.4) has suffered or is likely to suffer:
  1. loss in consequence of the dishonesty of a [defaulting practitioner](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) or the employee or [manager](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#manager) or [owner](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#owner) of a [defaulting practitioner](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner); or
  2. loss and hardship in consequence of a failure to account for money which has come into the hands of a [defaulting practitioner](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) or the employee or [manager](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#manager) or [owner](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#owner) of a [defaulting practitioner](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner), which may include the failure by a [defaulting practitioner](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) to complete work for which the [defaulting practitioner](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) was paid, in the course of an activity of a kind which is part of the usual business of a [defaulting practitioner](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) and, in the case of a [defaulting licensed body](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner), the act or default arose in the course of performance of an activity regulated by the [SRA](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) in accordance with the terms of the body's licence.
3. For the purposes of rule 3.1(b):



1. an individual whose dealings have been in a personal capacity with the [defaulting practitioner](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] and who has suffered or is likely to suffer loss due to a failure to account shall be deemed to have suffered hardship; and
2. a body corporate, or an individual whose dealings have been in a business capacity with the [defaulting practitioner](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] and who has suffered or is likely to suffer loss due to a failure to account must provide evidence to satisfy the [SRA](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] that it, he or she (the body or individual) has suffered or is likely to suffer hardship.
3. The [SRA](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] may make a grant as an interim measure.
4. A [person](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#person) [\[https://media.sra.org.uk/solicitors/standards-regulations/glossary/#person\]](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#person) is eligible under this rule to apply for a grant out of the [Fund](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#Fund) [\[https://media.sra.org.uk/solicitors/standards-regulations/glossary/#Fund\]](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#Fund) where the [person](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#person) [\[https://media.sra.org.uk/solicitors/standards-regulations/glossary/#person\]](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#person):
  1. is an individual; or
  2. at the time the application is made, is a sole trader, [partnership](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#partnership) [\[https://media.sra.org.uk/solicitors/standards-regulations/glossary/#partnership\]](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#partnership), body corporate, unincorporated association or mutual association with an annual [turnover](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#turnover) [\[https://media.sra.org.uk/solicitors/standards-regulations/glossary/#turnover\]](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#turnover) of less than £2 million, and does not fall within rule 4.2, 4.3(a) or 4.4(a).
5. A [person](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#person) [\[https://media.sra.org.uk/solicitors/standards-regulations/glossary/#person\]](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#person) is eligible under this rule to apply for a grant in the circumstances set out in rule 3.1(a) if at the time the application is made the [person](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#person) [\[https://media.sra.org.uk/solicitors/standards-regulations/glossary/#person\]](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#person) falls within one or more of the following categories:
  1. a [charity](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#charity) [\[https://media.sra.org.uk/solicitors/standards-regulations/glossary/#charity\]](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#charity) with annual income net of tax in the most recent financial year of less than £2 million; or

1. at the time the application is made falls within one or more of the following categories:
  1. a [charity](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#charity) [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#charity] with annual income net of tax in the most recent financial year of £2 million or more; or
  2. a [trustee](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#trustee) [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#trustee] of a trust with an asset value of £2 million or more; and
2. has satisfied the [SRA](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] that its beneficiaries have suffered, or are likely to suffer, hardship if a grant is not made.
5. The [SRA](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] may take into account such evidence as it sees fit when determining eligibility under rules 4.1 to 4.4 and may make a broad estimate of any relevant amount.

## **Rule 5: Defaulting practitioners**

The SRA may only make a grant in respect of acts or omissions of a [defaulting practitioner](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner], or of a [defaulting practitioner's](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] employee, [owner](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#owner) [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#owner] or [manager](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#manager) [https://media.sra.org.uk/solicitors/standards-regulations/glossary/#manager] as appropriate, which fall within rule 3.

16. In the case of a [defaulting licensed body](#) [\[https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner\]](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner), the [SRA](#) [\[https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA\]](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) will consider the extent to which the loss is attributable to an act or omission which falls outside the performance of an activity regulated by the [SRA](#) [\[https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA\]](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) in accordance with the terms of the body's licence in deciding whether to make a grant and, if so, the amount of any grant.

### **Rule 16: Application and time limit**

An [applicant](#) [\[https://media.sra.org.uk/solicitors/standards-regulations/glossary/#applicant\]](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#applicant) must make an application for a grant in the [prescribed](#) [\[https://media.sra.org.uk/solicitors/standards-regulations/glossary/#prescribed\]](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#prescribed) form, and within 12 months of the date they first became aware, or should reasonably have become aware, of the loss.
17. The [SRA](#) [\[https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA\]](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) may extend the 12 month period in rule 16.1 if satisfied that there are circumstances which justify the extension of the time limit.

The [SRA](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [\[https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA\]](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) may not make a grant unless it has given not less than 8 days' notice to the [defaulting practitioner](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [\[https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner\]](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) informing them of the nature and value of the application, unless it appears to the [SRA](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [\[https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA\]](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) that it would not be reasonably practicable to give such notice, or the grant should be made urgently.

If the [SRA](#) [\[https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA\]](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) refuses to make a grant of either the whole or part of the amount applied for, the [applicant](#) [\[https://media.sra.org.uk/solicitors/standards-regulations/glossary/#applicant\]](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#applicant) will be informed in writing of the reasons for the decision.
20. The fact that an application has been rejected does not prevent a further application being submitted provided that material new relevant evidence or information is produced in support of the new application.

Where an [applicant](#) [\[https://media.sra.org.uk/solicitors/standards-regulations/glossary/#applicant\]](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#applicant) intends to or has already instituted proceedings for recovery of their loss and wishes to apply for a grant in respect of the costs of the proceedings, the [SRA](#) [\[https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA\]](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) will only consider such costs where:
  1. they can be shown to be proportionate to the loss and the amount likely to be recovered; or
  2. the proceedings were necessary for the making of an application to the [Fund](#) [\[https://media.sra.org.uk/solicitors/standards-regulations/glossary/#Fund\]](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#Fund).
21. Where a grant is made, the [SRA](#) [\[https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA\]](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) may consider an application for a further grant in respect of the reasonable costs properly incurred by the [applicant](#) [\[https://media.sra.org.uk/solicitors/standards-regulations/glossary/#applicant\]](https://media.sra.org.uk/solicitors/standards-regulations/glossary/#applicant) with either their solicitor or other professional adviser, provided that such costs were incurred wholly, necessarily and exclusively in





connection with the preparation, submission and proof of the application.
