#### **Decision details**

Mr Panesar's practising certificate for 2024/2025 is subject to the following conditions:

- 1. Mr Panesar is not to be a manager or owner of any authorised body or authorised non-SRA firm.
- 2. Mr Panesar may not act as a compliance officer for legal practice (COLP) or compliance officer for finance and administration (COFA) for any authorised body.



3. Mr Panesar may not provide reserved or unreserved legal services on his own account under Regulation 10.2(a) and (b) of the SRA Authorisation of Individuals Regulations.

#### Reasons/basis

The above conditions are necessary in the public interest. They are reasonable and proportionate having regard to the purposes set out in regulation 7 of the SRA Authorisation of Individuals Regulations, and the regulatory objectives and principles governing regulatory activities as contained in section 28 of the Legal Services Act 2007.
