### **Outcome details**

This outcome was reached by SRA decision.

#### **Reasons/basis**

This notification relates to a Decision to prosecute before the Solicitors Disciplinary Tribunal. This is an independent Tribunal which will reach its own decision after considering all the evidence, including any evidence put forward by the Solicitor. The Tribunal has certified that there is a case to answer in respect of allegations which are or include that:-

1. Between approximately 17 January 2022 and 12 May 2023, he made or allowed to be made improper withdrawals across 38 invoices from 10 client matters, resulting in a minimum shortage on the firm's client account.
2. Failed to replace the minimum shortage outlined at allegation 1 promptly, or at all.
3. Between October 2012 and July 2022, on five probate matters, failed to notify the executors of costs prior to transferring funds, or at all.
4. Between approximately 31 December 2015 and 28 April 2023, caused or allowed the firm to overcharge the estates of two individuals (deceased), of which he was an executor.

The allegations are subject to a Hearing before the Solicitors Disciplinary Tribunal and are as yet unproven.

2. The panel is satisfied there is reason to suspect dishonesty on the part of Mr Davies in connection with his practice at the firm (paragraph 1(1)(a)(i) of Schedule 1 to the Solicitors Act 1974 (as amended))
